Offers are invited on behalf of Director, NEIGRIHMS, Shillong for disposal of Vehicle, in sealed cover, addressed to the Deputy Director (Admn.), NEIGRIHMS, Mawdiangdiang, Shillong – 793018 with the words "Tender No & Date", with due date boldly superscribed on the top of the envelope and dropped in the Tender Box of the Institute placed near Store & Procurement Section, Top Floor, Director's block of the Institute.

Bidders should note that the following terms and conditions will apply specifically in addition to the Rules and regulations applicable to purchases in the Government of India.

1. Please note that no counter proposal is acceptable to us and conditional /late tenders are liable to be rejected.
2. Subject to realization of reserve price where the same has been fixed by NEIGRIHMS, Shillong, Vehicles shall be sold to the bidder (s) quoting the highest price.
3. Bidders have to submit non-refundable DD/Banker's cheque, in favour of Financial Adviser, NEIGRIHMS, Shillong, of Rs. 100.00 (One hundred only) by post and Rs.110.00 (One hundred Ten only) by post as tender fee. Earnest Money, equal to ten percent (10%) of the reserve price, for each vehicle, has to be submitted along with the quotation. Earnest Money, valid for six month, to be deposited in the form of Bankers Cheque/Bank draft in favour of Financial Adviser, NEIGRIHMS, Shillong which will be released to them on finalization of sale. Quotations received with out Earnest Money will not be accepted.
4. The buyer will have to deposit the full payment of the sale value in the form of Bankers Cheque/Bank draft in favour of Financial Adviser, NEIGRIHMS, Shillong, within 7 (seven) days of acceptance of his /their offered rate.
5. EMD of the unsuccessful bidder will be refunded after finalization of the tender.
6. The Earnest Money of the successful bidder will be refunded on receipt of full payment from the buyer and on lifting the Vehicle from the Institute's premises.
7. In case the selected bidder does not show interest in lifting the Vehicle within the stipulated period, the bid security shall be forfeited and other actions initiated including re –sale of the vehicle in question at the risk and cost of the defaulter, after obtaining legal advice or approval from the competent authority.
8. The Vehicle will be sold on 'as is' and 'where is' basis. The vehicles will be sold on the assumption that the bidder (s) have inspected the vehicles and know that they are buying.
9. Interested Bidder (s) can inspect the Vehicles at the Institute's premises, on all working days & hours. In respect of Mahindra Bus, the bidders may inspect the vehicle, parked at the Interim Hospital Facility (IHF) campus located at Lawmali (near Pasteur Institute –Blood Bank).
10. The Vehicle shall remain where they are in every aspect at the risk of the buyer (s) from the date of acceptance of his /their offer by NEIGRIHMS and NEIGRIHMS shall not be under any liability for the safe custody or preservation thereof from the date onwards.
11. The Vehicle shall be taken from the site where they are parked with all faults and errors in description, if any, and no warrantee or guarantee shall be implied. NEIGRIHMS will issue sale release order signed the competent authority /authorized officer to the buyer on production of full payment receipt.
12. Delivery of the Vehicles will be made only during working hours on all working days. The purchaser (s) will make own arrangements for transportation of the Vehicle (s) and he will not be entitled to claim any facilities from NEIGRIHMS.
13. Rate quoted should be inclusive of all Taxes, Transportation or any other unforeseen charges.
14. Settlement of disputes – Director, NEIGRIHMS or his authorized representative shall be the final authority in all disputes and decision will be binding on all concerned.
